The first of 10 equal payments is due May 10, 2011.

Instructional Materials-Technology-Books fee and Lunchroom fee are due in July. The second tuition (10%) payment is due in August. Payments #3-#10 will be due on the 10th of each month during the school year from September to April.

Remember that we accept VISA/MASTERCARD for all tuition payments.

***Fundraising:** Each family earns \$300 goal in percentage credits from March 1, 2011 to February 29, 2012 or may issue direct payment of \$300.

****Parishioner Rate:** Will be a matter of stewardship, recognizing the needs of individual families. Our goal is that all families should actively support parish life and attend Sunday Mass, making a reasonable financial contribution to qualify for the parishioner tuition rate.
